Dear Illinois General Assembly Member,

The more than 100 undersigned organizations urge you to include at **least \$30.1 million in funding for the Illinois Department of Public Health (IDPH) for grants to certified local health departments via the Local Health Protection Grant (LHPG).** This amount would restore the \$5 million reduction currently proposed in the SFY2025 budget (\$20.1M) for the department and increase the LHPG appropriation by an additional \$5 million to support the critical services provided by local health departments to ensure the health of our population.

Our organizations are strongly opposed to the proposed reduction in funding which would be damaging to local health departments throughout the state. The SFY2024 LHPG appropriation increase, passed by the General Assembly, was the first significant funding change for the state's 97 certified local health departments (LHDs) in almost two decades and was critical to help them continue to fulfill their statutory requirements as delegate agencies of IDPH.

Certified local health departments in Illinois are on the front lines fulfilling their mandates to protect the public by ensuring safe water, disease control and prevention, safe food, and acting as agents of the State of Illinois for the protection of our communities. The \$5 million in new LHPG funding appropriated for SFY2024 was a turning point and helped address some of the unprecedented demands on the public health system as a result of the COVID-19 pandemic. The grant increases led to new minimum funding levels, which allowed LHDs to replace critical staff who retired or left the public health sector and restart programs to accomplish statutory requirements. Reducing funding to SFY2023 levels endangers the ability of local health departments to maintain these staff and continue to effectively implement the vital programs which ensure health protection in our counties.

The undersigned organizations are committed to championing optimal, equitable health and well-being for all. Ensuring adequate funding for certified local health departments to support their workforce, act as agents for the state of Illinois, and protect the health and safety of our communities is critical. Despite the funding increase in FY2024, Illinois' certified local health departments remain woefully underfunded. We urge you to include at least \$30.1 million for the Local Health Protection Grant in the FY2025 State of Illinois Budget appropriation bill as provided by HB4823/SB3301 as amended.
